The Master's degree awarded by the university is fully recognized within the territory of the Republic of Uzbekistan.

INTI's courses are locally certified by the Malaysian Qualifications Agency (MQA) as well as being internationally recognized by UK's leading universities, such as FedEx, Shell, Unilever, Intel and the University of Hertfordshire.

Kimyo International University in Tashkent and INTI International University are offering a joint degree program. This initiative combines KIUT's Master of Science in Corporate Finance with INTI's Master of Business Administration (MBA), setting a new benchmark for academic excellence and international collaboration.

Program details:

- **Dual Certification:** Upon successful completion of the program, graduates will be awarded two prestigious certificates - an M.Sc. in Corporate Finance from Kimyo International University and an MBA from INTI International University. This dual certification offers graduates a competitive edge in the global job market.
- **Internship Opportunities:** The program includes tailored internship placements, facilitating practical experience in multinational companies and major local enterprises within both regions.

Applications for admission to the Master's program are carried out ONLINE via the university's platform at masters.kiut.uz from April 1 to August 1, 2024, by submitting the following necessary documents for registration to participate in the entrance exams:

- Copy of passport or ID card (**colour**);
- Copies of the diploma of higher education and its supplements (**colour**);
- Electronic photograph (size 3.5×4.5 cm, taken within **the last 3 months**).

All documents are accepted electronically via the masters.kiut.uz platform.

For this joint program applicants should hold international certificates of higher proficiency in English.

Master's students admitted on a contract basis are given the opportunity to continue their studies based on the university's educational grant (educational grants are allocated annually by the founders of the University to stimulate self-education among young people, support talented students, and those in need of social protection);

Applicants who pass entrance exams have the opportunity to participate in international student exchange programmes and internships abroad, as well as at major enterprises and organizations during the course of their studies.
